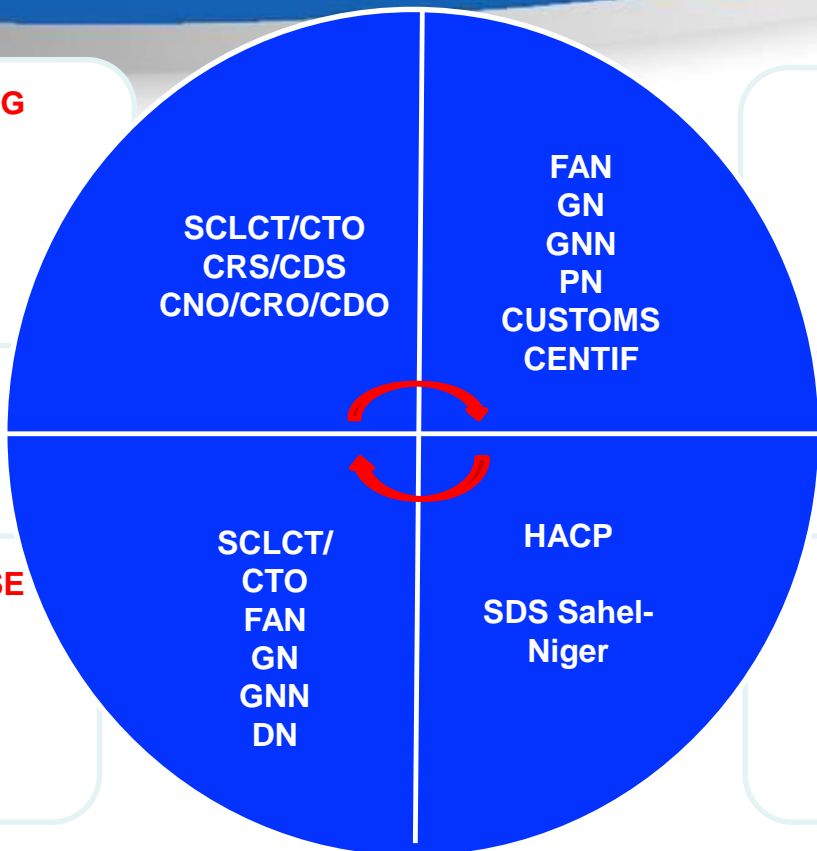

- ☞ **Niger – centrality of many areas affected by crises and conflicts – often subjected to deadly violence perpetrated by **terrorists and criminals**;**
- ☞ **Aggravating factors of insecurity, hybrid threats and the imbalance of war **limit current security activities**;**
- ☞ **The need to deal with new security threats through a **broad-based approach** that combines development and security (**political will**);**
- ☞ **The President of the Republic’s decision to create the National Center for Strategic and Security Studies (CNESS, January 15, 2015), a strategic forecasting and monitoring entity:**
 - ❖ in cooperation with the appropriate services and institutions, conduct prospective analyses and studies on national and international strategic and security issues.
- ☞ **CNESS has implemented a specific program to develop and propose to the government a National Security and Defense Policy (PNSD):** in accordance with its Strategic Direction Plan (POS) 2017-2019.

As a frame of reference for the security and defense sectors, the PNSD is: accessible to leaders and citizens, adapted to the national, regional and international security context, and part of a common approach to security

❖ The overall objective of the implemented process is to develop a consistent national security and defense policy to prioritize national goals and interests, serving as a reference for national sector strategies in accordance with this Policy.

❖ *Specifically, these objectives are:*

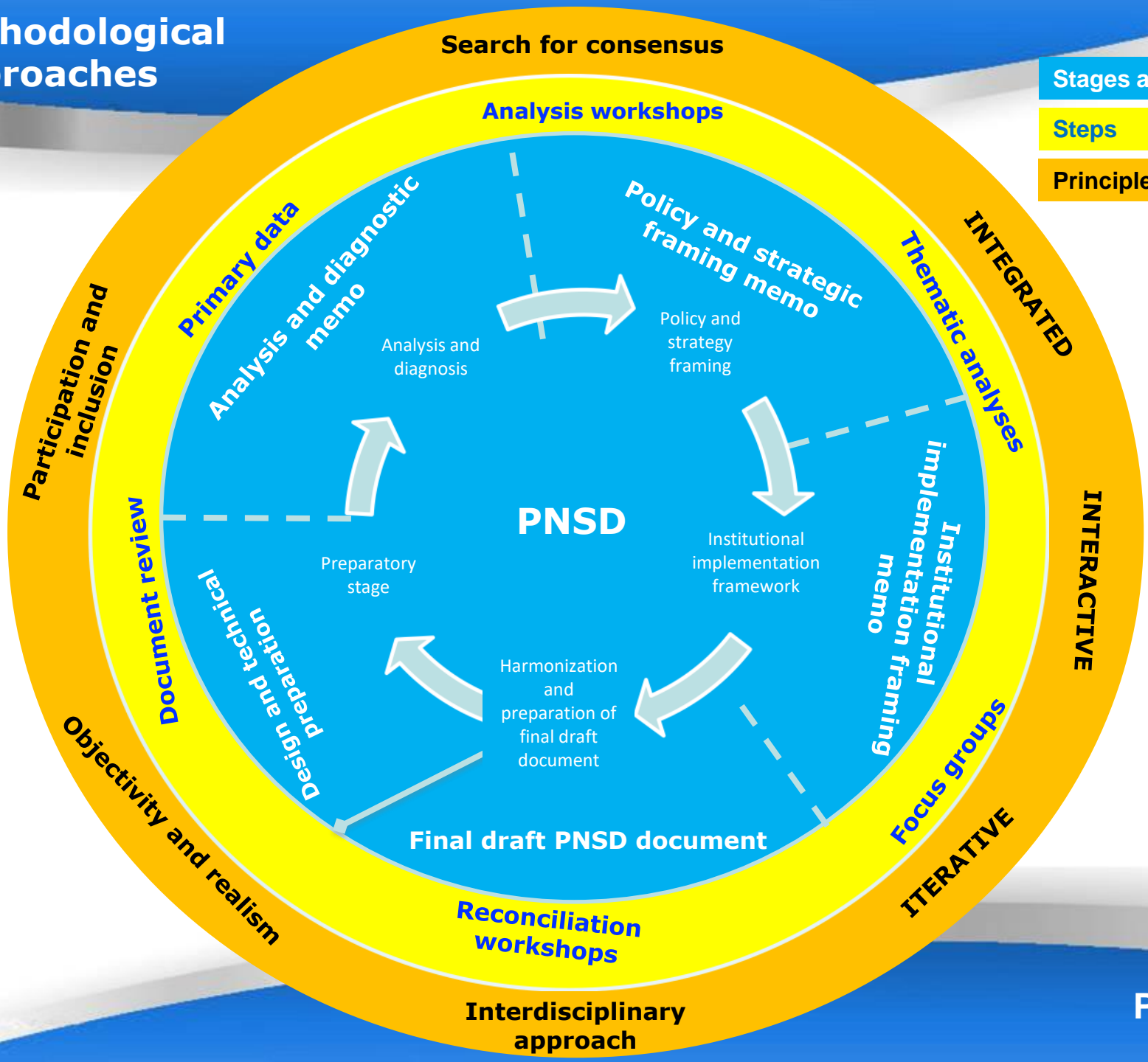
- ❑ Create an inclusive national framework for discussion of security and defense, bringing together FDS superior officers, high-level government officials, universities, representatives of civil society and partners
- ❑ Prepare an assessment of the security and defense sectors
- ❑ Define reliable indicators for the security sector that take into consideration the national, regional and international context

The PNSD process was officially launched during the first National Forum on Security and Defense (December 2017) in Niamey

- **Political support (Presidency of the Republic) facilitates the mobilization and integration of synergies;**
- **The integration of both civilian and military stakeholders is a success factor in the implementation of the process; appropriation of the security issue by citizens;**
- **Stage 1: both time and resource-intensive since it is the fundamental stage in developing appropriate policies and strategies;**
- **Appropriate financing: national budget**
 - Guarantee of autonomy in analysis and strategic direction;
 - However, there are difficulties in mobilizing resources in a timely manner: limited budgetary resources;
 - And a lengthy procedure that leads to delays in implementing the process.

Developing the PNSD....

- **AN INNOVATIVE AND AMBITIOUS PROJECT**
 - ❖ Inclusive framework for discussion between civilians and the military
 - ❖ Develops national expertise
 - ❖ Financed through the national budget
 - ❖ Evaluates all security and defense sectors

- **A CHALLENGING PROJECT**
 - ❖ Availability of resources
 - ❖ Balance between transparency and confidentiality
 - ❖ Financing of PNSD implementation

- **AN PROJECT THAT IS ACHIEVABLE THROUGH THE COMMITMENT OF ALL PARTIES**
 - ❖ Political will
 - ❖ Sustained commitment of CNESS leadership
 - ❖ Stakeholders' commitment to work together for a noble cause
