Leadership

Daniel Hampton is the Acting Director of the Africa Center for Strategic Studies, located at the National Defense University in Washington, DC. Prior to this appointment, he held the position of Chief of Staff, Associate Dean of Academic Affairs, and Professor of Practice, Security Studies within the Africa Center. During the course of a 30-year military career, Colonel (retired) Hampton held several postings on the African continent to include the United States Senior Defense Official to the Republic of South Africa and U.S. Defense Attaché to the countries of Malawi, Lesotho, Eswatini, and Zimbabwe. He also served as a policy adviser to the Chairman of the Joint Chiefs of Staff on the Horn of Africa region. From June 2009 to June 2010, as part of the NATO Training Mission, Colonel Hampton commanded Regional Support Command-South in Kandahar, Afghanistan. In that capacity, he was responsible for the institutional training and resourcing of all Afghan Army and Afghan Police forces in southern Afghanistan. Colonel (retired) Hampton is a graduate of the Zimbabwe Staff College and the Defense Language Institute (French). He holds a Masters in African Studies from the University of Illinois, a Masters in Strategic Studies from the U.S. Army War College, and a B.A. in History from Wake Forest University.

Dr. Assis Malaquias is Academic Dean at the Africa Center for Strategic Studies, National Defense University, in Washington, DC. He oversees curriculum and program development in the Africa Center's lines of effort, including Advancing Military Professionalism; Countering Transnational Organized Crime; Countering Violent Extremism and Countering Terrorism; Cyber Domain Awareness, Cybersecurity and Information/Disinformation; Maritime Safety and Security; National Security Strategy Development; Peace Support Operations and Crisis Response; and Rule of Law and Security Sector Governance. Prior to joining the Africa Center, Dr. Malaquias served as Professor and Chair in the Department of Global Studies and Maritime Affairs at the California State University Maritime Academy. Dr. Malaquias' previous positions included: Professor and Chair of Defense Economics and Resource Management at the Africa Center for Strategic Studies, associate dean of international and intercultural studies and professor of government at St. Lawrence University in Canton, NY; extraordinary associate professor of political studies at the University of Western Cape in South Africa; and a visiting professor at Stellenbosch University in South Africa. He holds an M.A. in economics and a Ph.D. in Political Science from Dalhousie University, Canada.

Dr. Nate Allen is an Associate Professor at the Africa Center for Strategic Studies oversees academic programming on cyber issues and peace operations. Dr. Allen's expertise includes cyber issues, emerging technology, civil-military relations, and regional security

partnerships across Africa. Previously, Dr. Allen was a policy advisor at the U.S. Institute of Peace (USIP) Task Force on Extremism in Fragile States. He has also worked at the U.S. State Department, House of Representatives, and as a research analyst at NORC at the University of Chicago. Dr. Allen's work has appeared in a wide range of leading policy and peer-reviewed publications, including *Armed Forces and Society*, *The Washington Quarterly*, *Democratization*, *Orbis*, *War on the Rocks*, *The Washington Post*, and *Foreign Affairs*. He has received fellowships from American University, the Robertson Family Foundation, and USIP, where he was a 2016-2017 Peace Scholar. He currently serves as a Research Fellow at South Africa's Stellenbosch University and is a Council on Foreign Relations Term Member. Dr. Allen holds a Ph.D. in international relations and African studies from the Johns Hopkins University School of Advanced International Studies, an M.A. from Princeton University's School of Public and International Affairs, and a B.A. from Swarthmore College.

Dr. Rachel Adams is the Founder and CEO of the Global Centre on AI Governance, and a Senior Research Associate at the Leverhulme Center for the Future of Intelligence, University of Cambridge. She is further a Research Fellow at The Ethics Lab at the University of Cape Town. She holds degrees in English Literature, International Human Rights Law and Philosophy. She serves on numerous international expert committees including for UNESCO, the UN, UNDP, the Bill and Melinda Gates Foundation and the Global Partnership on AI. She advises policymakers around the world on AI governance and was one of the lead drafters of the African Union Commission's Continental AI Strategy. In November 2024, Rachel's third book *The New Empire of AI: The Future of Global Inequality* was published with Polity Press.

Dr. Chinasa T. Okolo is a Fellow at The Brookings Institution and a recent Computer Science Ph.D. graduate from Cornell University. Her research focuses on AI governance for the Global Majority, datafication and algorithmic marginalization, and the socioeconomic impact of data work. Dr. Okolo has been recognized as one of the world's most influential people in AI by *TIME*, honored in the inaugural *Forbes* 30 Under 30 AI list, and advises numerous multilateral institutions, national governments, corporations, and nonprofits. In addition to her work at Brookings, Dr. Okolo serves as a Drafting Member of the Nigerian National AI Strategy, a Consulting Expert to the African Union AI Continental Strategy, and an Expert Contributing Writer to the International Scientific Report on the Safety of Advanced AI. Her research has been covered widely in media outlets and published at top-tier venues in human-computer interaction and sociotechnical computing.

Mr. Baudouin Akoh is an experienced Political Affairs and Security Specialist with over 15 years of expertise in international peacekeeping, conflict resolution, and strategic advisory roles. He has worked extensively in volatile environments, specializing in disarmament, humanitarian security, and multilateral diplomacy. Currently serving as the National Liaison and Security Officer for the United Nations Development Program (UNDP) Cameroon, Baudouin plays a crucial role in stakeholder engagement, conflict analysis, and security risk management, advising senior leadership on critical security trends. Abdul-Hakeem B. D. Dr. Segun has published over 15 peer-reviewed articles in leading journals and conferences on AI safety, data and computational ethics, algorithmic audit, responsible AI, and technology policy. He is the editor of the following works, AI Ethics & Governance in Africa, Selected Issues in the Ethics of AI, Conversations on African Philosophy of Mind, Consciousness and AI.

Dr. Amegboh holds a Ph.D. in Conflict Analysis and Resolution from the Jimmy and Rosalynn Carter School for Peace and Conflict Resolution at George Mason University, an M.A. in Global Development and Peace Studies, and a B.A. in International Political Economy and Diplomacy from the University of Bridgeport in Connecticut. He is a Council on Foreign Relations Term Member.

Dr. Yasmin Afina is a Researcher for the Security and Technology Programme at UNIDIR, where her research covers the intersection between international security, international law and artificial intelligence. Her research experience and interests cover nuclear weapons policy, outer space security, and wider international security and policy issues surrounding emerging technologies, including neurotechnology, quantum technologies, and cyber. Yasmin is also a PhD Researcher in law at the University of Essex. She holds an LLM from the Geneva Academy of International Humanitarian Law and Human Rights, an LL.B. from the University of Essex, as well as a French Bachelor of Laws and Postgraduate degree (Maîtrise) in International Law from the Université Toulouse I Capitole. She previously worked as Research Fellow at Chatham House, where she led the Institute's work on AI policy, and notably testified in front of the UK House of Lords' AI in Weapon Systems Select Committee. Yasmin has published over a dozen research papers, op-eds and commentaries on technology policy (including AI, cyber, and neurotechnology) and nuclear non-proliferation and disarmament, and her work has been cited by a number of media outlets, including the BBC, Politico, and Al Jazeera. Yasmin speaks English, French and Indonesian.

Dr. Barbara Glover is a dedicated advocate for science, technology, and innovation in Africa. With a background in innovation and emerging technologies and extensive experience in research and policy, Dr. Glover currently serves as the Programme Manager of the African Union High-Level Panel on Emerging Technologies at the African Union Development Agency-NEPAD (AUDA-NEPAD). In this role, she works towards harnessing scientific advancements for the sustainable development of the continent. Dr. Glover's passion lies in promoting collaborative efforts that leverage technology for positive impact across diverse sectors. Her current work builds upon experiences working since 2016 at AUDA-NEPAD in aiding African countries identify, harness and implement emerging technologies for Africa's socioeconomic development. In this role, she supports conducting research and analyzing data on topical issues such as AI, conducting evidence-based analysis of STI, drafting policy recommendations and guidelines for deploying emerging technologies, and contributing to the development and implementation of capacity building programs in science, technology, and innovation for building a culture of innovation among the youth.

Dr. Mark Duerksen is a Research Fellow at the Africa Center for Strategic Studies. His research focuses on Africa's unparalleled urbanization and the security challenges and opportunities this shifting landscape presents. His current work includes analysis of Nigeria's diverse security threats as well as the growing impact of FIMI (Foreign Information Manipulation and Interference) campaigns on the continent's rapidly changing information systems. Trained as a historian, he brings deep knowledge of the underlying material, governance, social, and developmental dynamics driving current tensions and conflicts in and around the continent's cities. Dr. Duerksen's projects at the Africa Center include tracking strategic communication and demographic trends across the continent and creating analytic maps and infographics to visualize spatial patterns and historical precedents. His maps of Lagos have been recognized through various awards, and his Africa Center *Infographics* have been reproduced and shared widely. His background includes training in Geographic Information Systems (GIS) and writing on African art and architecture. In his 2024 book, *Waterhouses*, Dr. Duerksen traces the strategic importance of water and housing in Lagos's rise as an African megacity and its future resilience. Dr. Duerksen holds a Ph.D. in African History from Harvard University and a BA in Political and Social Thought from the University of Virginia. His dissertation research on the history of Lagos's ecology, housing, and politics was funded by a Boren Fellowship and a Frederick Sheldon Fellowship (Harvard). Previously, he taught at Hunter College in New York and the African School of Economics in Benin.

Dr. Giacomo Persi Paoli is the Head of the Security and Technology Programme at the United Nations Institute for Disarmament Research (UNIDIR). With over two decades of experience, he specializes in the implications of emerging technologies - particularly artificial intelligence and cyber - on international peace and security. His recent work focuses on the governance of these transformative technologies, including their impact on arms control, strategic stability and global security frameworks. Dr Persi Paoli holds prominent advisory roles in shaping the governance of emerging technologies. He is a member of the Expert Advisory Group of the Global Commission on Responsible AI in the Military Domain and serves as Co-Chair of the Think7 Task Force on Transformative Technologies: AI and Quantum, leading global policy discussions on the responsible development and application of these innovations. Before joining UNIDIR, he was Associate Director at RAND Europe, where he led the defence and security science, technology and innovation portfolio. He also directed the Centre for Futures and Foresight Studies, focusing on scenario planning and strategic forecasting. Earlier in his career, he spent 14 years as a warfare officer in the Italian Navy, gaining extensive operational and

leadership experience. Dr Persi Paoli holds a PhD in Economics from the University of Rome, a master's degree in Political Science from the University of Pisa and a master's degree in International Affairs and Diplomacy at the University of Trieste. Fluent in English, French and Italian, he is a recognized voice in international security, actively supporting multilateral processes aimed at shaping the governance of emerging technologies. He regularly engages with policymakers and publishes research on the security implications of AI and cyber technologies, fostering collaboration across the international community.

Dr. Lauren Sanders is a Senior Research Fellow with the TC Beirne School of Law, The University of Queensland in the Law and Future of War project. Lauren's current research focus is on the application of export control, arms trade and sanctions regimes relevant to the export and brokering of trusted autonomous military systems and associated technology. Her broader research and teaching interests include international criminal law, international humanitarian law and domestic counter-terrorism law. She is the editor of UQ's Law and Future of War podcast where she interviews experts in the fields of law and emerging and disruptive technology, military strategy and military affairs. She completed her initial law studies with The University of Queensland, along with a Bachelor of Arts in Peace and Conflict Studies. Her PhD studies were completed at the Australian National University focused on the practical application of universal jurisdiction. She holds an LLM in Legal Practice, Masters in Defence and Strategic Studies and numerous Graduate certificates in military law. Before returning to The University of Queensland, Lauren spent twenty years as an Australian Army signals officer and legal officer, and has served in Iraq, Afghanistan and East Timor and on humanitarian assistance and disaster relief operations, a legal advisor to ADF domestic counter-terrorism operations, and an assistant Inspector-General of the ADF. She is a graduate of the Australian Command and Staff College, and was awarded a Conspicuous Service Cross for her work as the Command Legal Officer within Special Operations Command.
